## Infrastructure

- There are 5.2 Kilometres of C roads
- 7 kilometers of Unlisted roads
- 17.1 kilometers of Public right of way
- All are maintained by Balfour Beatty
- The Parish has a 'lengthsman' whose duties are removing fly tipping waste, digging/ clearing ditches, clearing entrances to the public right of ways and other works asked for by the Parish council
- The Parish has electricity, water and mains sewerage (but not to all properties)
- Telephone access is available and a limited broadband service operates (but not to all properties)
- There is limited street lighting around the Parish but new developments have been supplied with much higher levels of lighting

Would you like your lengthsman do more for the village in bad weather? Do your broadband and mobile services operate effectively and do they meet your needs? What needs improving? What do you think about the domestic drainage system? Are surface water management and the disposal of effluent from septic tank systems a concern to you? How could local shops and services be encouraged to develop? Are you on mains drainage? Is this an issue for you? Have you seen a significant improvement in your electric supply in recent years? Are there still too many power cuts? Are you satisfied with local communications systems? Do you use oil, LPG or natural gas from the gas network? Which? Would you have a preference if there was the possibility to change? If so, what to?

If so why and what could be done to improve this in the future?
