GDPR – ICO Registration

On 25 May 2018, the Data Protection (Charges and Information) Regulations 2018 (the 2018 Regulations) came into force, changing the way we fund our data protection work.

Under the 2018 Regulations, organisations that determine the purpose for which personal data is processed (controllers) must pay a data protection fee unless they are exempt.

The new data protection fee replaces the requirement to 'notify' (or register), which was in the Data Protection Act 1998 (the 1998 Act).

Although the 2018 Regulations come into effect on 25 May 2018, this doesn't mean everyone now has to pay the new fee. Controllers who have a current registration (or notification) under the 1998 Act do not have to pay the new fee until that registration has expired.

From 1 April 2019, the Data Protection (Charges and Information) (Amendment) Regulations 2019 exempted the processing of personal data by members of the House of Lords, elected representatives and prospective representatives.

'Elected representatives' is defined by the Data Protection Act 2018 and includes, but is not limited to, MPs, MSPs, AMs in Wales, MEPs, elected councillors in county councils, district councils, London boroughs, parish councils, elected mayors and police and crime commissioners.

'Prospective representative' refers to anyone seeking to become an elected representative as defined above.

On 1 April 2019, the Data Protection (Charges and Information) (Amendment) Regulations 2019 added a new exemption. This exemption includes locally elected members.

In accordance with the Electoral Registration and Administration Act 2013, Herefordshire Council is required to complete a full review of all polling districts, polling places and polling stations every five years. The review must be held within a 16 month period between 1 October 2018 and 31 January 2020 with a public consultation forming part of that review. That review has now taken place and the results published.

Domestic Abuse Strategy and services for Herefordshire

As domestic abuse and the devastating impact it has on families and communities continues to feature in the national press, we wanted to make you aware of work taking place in Herefordshire to raise awareness and support victims and their families.

Domestic Abuse Strategy

Earlier this year, the council's Cabinet approved a Domestic Abuse Strategy for Herefordshire. Although approved by the council, this strategy is owned by a number of organisations including Wye Valley NHS Trust, the CCG and West Mercia Police, all of whom have signed up to support and deliver the strategy. The Community Safety Partnership has a working group dedicated to developing and steering a strategy delivery plan. A one page strategy and awareness raiser is currently in development which will be printed and issued to groups and organisations who work with people across all age groups and sectors. Herefordshire Council warns of the harmful effects of illegal tobacco

This 'Stoptober' Herefordshire Council is warning residents against smoking illegal tobacco due to its harmful effects on the body.

Illegal tobacco products include, cigarettes, hand-rolling tobacco, shisha or other tobacco goods that are counterfeit or have been smuggled or bootlegged into the UK.

Children and young smokers are often targeted by people who sell illegal cigarettes, making it even easier for them to get hooked on smoking. The people making money out of this are usually linked to criminal gangs, so they do not care who they sell to. Also, these illegal tobacco products do not display the health warnings required by UK legislation, so do not alert the customer to the serious health risks associated with them.

Hereford Crematorium supporting charities

The crematorium has been part of a national metal recycling scheme since 2011, which has allowed it to donate over £80,000 (and counting) to local charities.

The Institute of Cemetery and Crematorium Management (ICCM) launched their metal recycling scheme in 2005 as a way to recycle the metal recovered from cremated remains instead of burying them. Participating crematoria are asked to nominate a local bereavement charity to be given a share of surplus monies from the recycling process each year.

The service is provided at no cost to crematoria who have signed up to the scheme and metals are not recycled without the next of kin's permission, which is sought at the time of the funeral arrangements.

Protect yourself from Flu this winter

Herefordshire residents who are most susceptible to flu are being urged to make an appointment with their local GP practice or pharmacy to book a free flu vaccination as soon as possible. Vaccination against the flu virus is the single best protection against a potentially very serious illness.

This year, the NHS is offering the free flu vaccine to 25 million people across the country, with more people than ever being included in the vaccination campaign. Residents are eligible for a free NHS flu vaccination, if they fall under one of the following at-risk groups;

You can obtain free NHS flu vaccination from your GP or local community pharmacy if you are:

- Under 64 years with certain medical conditions;
- Over 65 years;
- Pregnant;
- A carer;
- Living in a long-stay residential care home or other long-stay care facilit;y

Children can receive the vaccine from their GP Practice if they are:

- Aged 2 to 17 years and have certain medical conditions
- Aged 2 or 3 years

At the cabinet meeting held on Thursday 26 September, elected members agreed to:

Accelerate a reduction of emissions and aspire to become carbon neutral by 2030/31. Deliver an updated carbon management plan and associated action plan for Council emissions by April 2020.

Work with strategic partners, residents and local organisations to develop a revised countywide CO2 reduction strategy aspiring for carbon neutrality by 2030.

Use 100% renewably sourced energy where this provides the best carbon reduction return on investment.

Council resolves to set a target of zero carbon emissions by 2030

Councillor Trish Marsh, Cabinet Member for Environment, Economy and Skills, said: "Climate change is a huge challenge that we must face together.

"The council acknowledges the very real threat that climate change poses to our planet and unanimously declared a Climate Emergency earlier this year".

Herefordshire Council has adopted the Travellers' Sites Development Plan.

The document, which will help fulfil the requirements for both residential and transit pitches, was discussed at a meeting of full Council last week (11 October) and confirmed via a majority vote.

The document forms part of the Local Plan and will allocate sites for a five year supply of the required number of pitches for Gypsies and Travellers, transit sites (for temporary stays and redirection from unauthorised encampments) and consider the need and approach to sites for Travelling Show people.

Extensive work and public consultation has been carried out to prepare this important document which identifies sites for a number of new pitches in order to meet the housing needs of the Gypsy and Traveller community.

A planning inspector scrutinised the DPD and all the supporting evidence, along with representations received, and public hearings were held in May 2018 and March 2019.

The new pitches identified in the plan are located at existing local authority sites at Grafton, Lower Bullingham, Bromyard and Pembridge. An extension to a private site near Bosbury, which has recently been granted planning permission, is also included. A site for a temporary stopping place on the outskirts of Leominster has also been identified for travellers passing through the County.
