Avian Flu - Herefordshire

As you may be aware, we're currently experiencing the biggest avian influenza outbreak we've ever had across the United Kingdom and just last week, there was an outbreak at Leigh Sinton on the Herefordshire border. On Monday, Defra announced that it will be a legal requirement for all bird keepers in Great Britain to follow strict biosecurity measures to help protect their flocks from the threat of avian flu. An avian influenza prevention zone (AIPZ) was brought into force at midday, **Monday 17 October 2022**. This means it is now a legal requirement for all bird keepers, small and large, to follow the new strict biosecurity measures to help prevent the disease spreading to more poultry and other domestic birds.

Avian influenza circulates naturally in wild birds. When they migrate to the UK from mainland Europe they can spread the disease to poultry and other captive birds.

Keepers with more than 500 birds need to comply with the minimum and enhanced biosecurity measures. These are to:

- Restrict access for non-essential people on their sites
- Ensure workers change clothing and footwear before entering bird enclosures
- Ensure site vehicles are cleaned and disinfected regularly to limit the risk of the disease spreading

There are requirement for backyard owners with smaller numbers of poultry, including chickens, ducks and geese to comply with the minimum biosecurity measures restrictions.

The recent Ofsted report has reinforced the fact that we need to work more closely with families and use their feedback to help us to improve over the next two years. The Council is also responding to concerns raised by our MPs where families have approached them directly, as have I been approached also. There is the need to ensure that any problems are effectively and efficiently addressed and if anybody has concerns in my ward over their children's treatment please contact me.

National changes to Telecare Service - please share

Some of you may have heard of 'digital switchover 2025', which is when existing analogue telephone lines, which use old copper wiring, will be switched off. This decision has been made by the communications industry which owns the copper lines due to the high cost of maintaining the infrastructure.

To replace the analogue lines, users nationally will be moved to a digital line which uses the internet connection to make and receive calls. The upgrade will be delivered by the telecoms industry in a phased approach over the next couple of years, with the UK network expected to be fully upgraded to in 2025. The switchover will happen on a telephone exchange by exchange basis (not on a regional basis).

This move affects the existing Telecare equipment as the majority of the current Lifeline units commissioned by the council use the analogue telephone lines to place the emergency calls. We'll therefore begin a changeover process across Herefordshire from 7 November 2022. This work is estimated to take about 18 months to complete.

During this time all existing analogue Lifeline units will be replaced with new hybrid units, which have the ability to work across both analogue and digital networks, and mobile phone networks. Using these new more versatile units will mean that we can meet all of our users' needs during this period of change.

The new Telecare equipment is supplied by a company called Tele alarm. If you're a Telecare prescriber within the Independent Living Service (ILS), the **new equipment will be visible for you to order on IRIS from 7 November**. In order for the transition to the new stock lines to take place, **ILS prescribers are asked not to place any orders for Telecare equipment after 2.30pm on Friday 4 November**.

So that prescribers can see the new equipment in action and ask questions, we have set up some short face-to-face sessions on Friday 4 November and Tuesday 8 November and you'll receive further information about how to book yourself onto one of these sessions soon.

We'll continue to release communications at each stage of the changeover process over the next 18 months in order to keep you up to date with what's happening. Initially, from 7

November we'll just be fitting the new equipment to brand new users of the Telecare Service and those whose analogue telephone lines have already been switched to digital.

Gritters ready to keep roads safe this winter

Herefordshire's gritting team were out on the roads last week carrying out their annual 'dry run' before winter. The safety of road users is our number one priority, so these trial runs are a crucial part of the preparations to ensure we are ready for the cold weather ahead. The gritters don't spread any salt during these runs but they are a good way to test all the equipment and systems in place, whilst also helping the drivers familiarise themselves with priority routes.

Balfour Beatty Living Places, working together with Herefordshire Council, deliver a winter maintenance service every year which covers 1000 miles of the county's roads. The service includes salting the roads with grit, which melts snow and ice and helps to prevent ice forming, snow ploughing and refilling thousands of grit bins across the county. Last winter, Herefordshire's gritting team completed 81 gritting treatments, most of which were carried out during the night.

Cost of Living Bulletin: October 2022

The [October 2022 Monthly Monitoring Report](#) has just been published. The monthly monitoring report is a supplementary report to the quarterly [Cost of Living Bulletin](#) and provides the latest data from the limited number of datasets that are updated on a monthly basis.



The key points from this edition of the Monitor are:

- The number of people claiming the Universal Credit (UC) doubled between March 2020 and May 2020. Since then the claimant numbers remained at a high level.
- The number of people claiming Pension Credit (UC) in Herefordshire has fallen significantly and fairly consistently since May 2018.
- Apart from the bump in early 2021, numbers of people claiming unemployment-related benefits have decreased gradually and fairly consistently from the peaks seen in May and August 2020. However, numbers remain elevated when compared to the pre-pandemic level. Generally, those wards with the highest numbers of claimants before the pandemic still have the highest numbers now.

Help shape the future of City's historic streets

A consultation has been launched on proposed improvements to the streets and public spaces in Hereford's historic Cathedral and River Wye Quarter.

Changes are being proposed for the layout and use of the streets and public spaces in the historic core of Hereford, around the Cathedral and the River Wye area - Broad St, King St and Bridge St, and surrounding areas.

The improvements aim to create an attractive, vibrant city centre to help support existing businesses and encourage people to stay longer when they visit, helping to boost the local economy.

The proposals give more space for pedestrians and cyclists, with a new layout and design that gives motor vehicles reduced priority. There are areas for small events, activities and street dining with lots of attractive seating and planting. The unique character and history of the area is a key consideration in the designs, along with making the area safe and enjoyable for all users.

The consultation closes on 8 November 2022.



The cost of the design proposals is being met through the Hereford City Centre Improvement programme, which is jointly funded by Herefordshire Council and Marches LEP. Once the final designs are agreed the funding for implementation, such as from grants, will then be sought.

Hereford Town Hall - future

The transfer of the freehold ownership of Hereford Town Hall from Herefordshire Council to Hereford City Council or designated body, is to be explored following a decision by Cabinet (Thursday 29 September 2022).

The decision follows a review of listed sites that focussed on the future of key buildings in the City, owned by Herefordshire Council. The review found that the listed status of Hereford Town Hall means that there are limited options for how Herefordshire Council could use the space in the future, or at the neighbouring 10 St Owen Street.

Hereford City Council have expressed an interest in both the sites for continued public and community use, and so it has been agreed to further explore the possibility of a transfer.

Hereford Station Transport Hub

It is understood and reported in the Hereford Times, that Hereford’s planned new central transport hub, which will now cost an extra £6.3 million. A proposal prepared for a Herefordshire Council cabinet meeting on Thursday (October 27) asks for the plan for an “integrated modern public transport interchange” in front of Hereford railway station to be signed off.

The scheme will enable passengers to switch easily between bus, rail, bicycle and taxi, in order to “support economic growth, improve accessibility and encourage active travel”, it says.

The design “incorporates as much greenspace as possible”, aims to keep people and vehicles separate, and also to enhance the grade II listed station building, it adds. According to an accompanying business case for the project, it will include bus stands, taxi ranks, covered waiting areas, real-time transport information, refreshments, toilets, Wi-Fi, CCTV, cycle parking and lockers, a Beryl bike exchange, and will have safe direct pedestrian access from the city centre. However the work will not include upgrading the station car park, or refurbishing the railway station building.
